Lansingburgh School Counseling Program:

MISSION: To provide a comprehensive, developmentally age appropriate and sequential counseling program that is aligned with the National (ASCA) and NYS (NYSCA) school counseling standards. Our program will address the academic, personal/social, and college and career readiness needs for all students in our district schools.

VISION: Our students will be prepared to reach their fullest educational potential and successfully manage their lives as healthy, independent thinkers, responsible and productive citizens who respect themselves and others.

GOALS:

- 1. To integrate Social Emotional Learning Curriculum in to Grades K-6.**
- 2. To review and strengthen current transition/orientation programs at the different buildings to insure student transitioning success.**
- 3. To develop sequential, age appropriate career development classroom curriculum to include all grade levels.**
- 4. Continue to increase the number of students graduating with an Advanced Regents Diploma.**
- 5. To implement additional programs and services to improve the school retention and attendance rate.**



New York State Part 100 Regulations - School Counseling Programs

The Lansingburgh Comprehensive Counseling Plan aligns with the amended Part 100 of the Commissioner's Regulations.

The Program

1. The Lansingburgh School District's comprehensive developmental counseling programs includes all students K-12.
1. All Lansingburgh students K-12 have access to a certified school counselor.
1. The Lansingburgh K-12, counseling program is designed in coordination with the teaching staff to prepare students to effectively participate in their current and future educational programs; address multiple student competencies including career/college readiness standards, academic, and social/emotional development standards. For students in grades K-5, the program is designed by a certified school counselor in coordination with instructional staff.

The Services

1. The Lansingburgh K-5 counseling program is designed:
 1. To prepare students to participate effectively in their current and future educational programs,
 2. To provide information related to college and careers,
 3. To assist students who may exhibit challenges to academic success, including but not limited to attendance or behavioral concerns, and
 4. Where appropriate, to make a referral to a properly licensed professional and/or certified pupil personnel service provider for more targeted supports.
1. Certified school counselors provide students at Lansingburgh Grades 6-12 with an annual individual progress review plan, which reflects each student's educational progress and career plans; for a student with a disability, the plan shall be consistent with the student's individual education program.



K-12 Comprehensive School Counseling Plan

1. For students in all grades K-12 the program includes the following activities or services:
 1. School counseling core curriculum instruction for the purpose of addressing student competencies related to career/college readiness, academic skills, and social/emotional development by a certified school counselor.
 2. Direct student services to enable students to benefit from the curriculum
 1. Responsive services
 2. Crisis response
 3. Group counseling
 4. Individual counseling, appraisal, assessment and advisement
 5. Assisting students to develop and implement postsecondary education and career plans
 6. Assisting students who exhibit attendance, academic, behavioral or adjustment concerns
 7. Encouraging parental involvement
 1. Indirect student services that enable student to benefit from their education
 1. Referrals to appropriately licensed or certified individuals
 2. Consultation and/ or collaboration with others
 3. Leadership, advocacy, and teaming activities

The Plan

1. The Lansingburgh CSD has developed a district-wide & building level comprehensive school counseling plan that complies with the regulation requirements and is in accordance with the following:
 1. Developed by or under the direction of certified school counselors
 2. The plan will be updated annually & a report will be presented to the board of education
 3. The plan is filed in the district office and is available for review by any individual
 4. The plan presents program objectives, which describe expectations of what students will learn
 5. Activities to accomplish the objectives; specifications of the staff members and other resources assigned to accomplish the objectives; provisions for the annual assessment of the program results

Student Mindsets and Behaviors

As a result of a comprehensive counseling program, students should demonstrate the following mindsets and behaviors as outlined by ASCA:

- **Academic Development** – Standards guiding school counseling programs to implement strategies and activities to support and maximize each student’s ability to learn.
- **Career Development** – Standards guiding school counseling programs to help students 1) understand the connection between school and the world of work and 2) plan for and make a successful transition from school to postsecondary education and/or the world of work and from job to job across the lifespan.
- **Social/Emotional Development** – Standards guiding school counseling programs to help students manage emotions and learn and apply interpersonal skills.

School counselors use these standards to assess student growth and development, guide the development of strategies and activities and create a program that helps students achieve their highest potential. To operationalize the standards, school counselors select competencies that align with the specific standards and become the foundation for classroom lessons, small groups and activities addressing student developmental needs. The competencies directly reflect the vision, mission and goals of the comprehensive school counseling program and align with the school’s academic mission.
